## Bios of the panellists



Mark Adams is the Principal Economist at the Joint Nature Conservation Committee (JNCC), the public body that advises the UK Government and devolved administrations on UK-wide and international nature conservation. Mark previously worked at Defra and before then in non-profit and academia in the United States. His current role includes combining economics and science-based and approaches to public policy problems including green finance and natural

capital.



**Farook Chaka** is a Fellow Chartered Certified Accountant and a serial Entrepreneur in his own businesses to include franchise businesses, catering, recruitment, construction, technology and innovation. Farook has vast experience of over 25 years in advising business in strategy, funding, structuring and financial systems together with compliance matters with HMRC and Corporate Governance. Farook's particular areas of interest are new business, innovation, seed

investments, cloud based business administration and compliance, and funding and venture capital investments.



**Richard Fitton** joined Finance Earth in 2019 and co-leads its Advisory business, focusing on corporate finance in the UK and internationally. Melissa Swartz is a senior advisor in the Environment Agency's Future Funding Department. With over 30 years experience working in the water and environment sector in four different countries, Melissa currently works with internal and external partners to enable investment into nature-based solutions that will deliver multiple benefits. ## The Keynote speaker



Vikas Agarwal is Distinguished University Professor of the University System of Georgia, and the Bank of America Distinguished Chair and Professor of Finance at Georgia State University's J. Mack Robinson College of Business. Vikas received his Ph.D. in finance from the London Business School. He is a Research Fellow at the Centre for Financial Research, University of Cologne, Germany. He also holds a Research Associate position at EDHEC Risk and Asset Management Center, France. He currently serves as a Director on the board of the Southeastern

Alternative Fund Association and on the academic advisory council of Decatur Capital Management. His broad areas of research interest include investments, household finance, private equity, and behavioral finance. His articles have appeared in leading academic journals, including the Journal of Finance, Journal of Financial Economics, Review of Financial Studies, Journal of Financial and Quantitative Analysis, Review of Finance, and Management Science. His research has been cited and discussed in the financial press and magazines including Bloomberg, Euromoney, Financial Times, Forbes, International Herald Tribune, New York Times, and The Wall Street Journal.



Ania Zalewska is Professor of Finance, Prestigious Research Chair, Director of Research (Accounting and Finance), Director of the Centre for Finance, Governance and Sustainable Growth (FGSG) in the Leicester University School of Business, and the Lead of the Green Finance TAG at the Land Use for Net Zero (LUNZ) Hub. She is a cross-disciplinary researcher with interest in the development of financial markets, institutional investors and corporations. She has published extensively in leading academic journals including Journal of Financial Economics, Management Science,

Economic Journal, and Journal of Corporate Finance, delivered keynote addresses at many academic and business conferences and workshops, and has been a member of scientific committees for numerous international research bodies including Max Planck Society's Dioscuri Centres of Excellence (Germany), and Fonds National de la Recherche (Luxembourg). She successfully mixes her academic career with advising numerous UK government bodies such as the Competition Commission, HMRC, the Committee on Standards in Public Life, FSA, DECC, BEIS, National Infrastructure Commission, oversees governmental bodies, and leading international companies and consulting firms on financial issues. She is a NED at the Southwest Heritage Trust. She has presented her research at leading policy organisations including IMF, and her opinions were featured in Financial Times, The Times, The Economist, The Hill, and many other international and national outlets.
